SCHEDULE A

BEGINNING at an old pipe in the Northern right of way line of Garden Place Drive (SR 1382, 60 foot right of way), said old pipe marks the Southeast corner of Lot 21 as shown on a map of Garden Place recorded in Map Book 9 page 1 of the New Hanover County Registry; running thence, from said Beginning point, with the Easternmost line of the above-mentioned Lot 21 North 9 degrees 10 minutes 05 seconds East 166.16 feet to an iron pipe; running thence, South 83 degrees 55 minutes 15 seconds East 298.66 feet to a point in the Western right of way line of US Highway \$117; running thence, with the Western right of way line of US Highway \$117 South 25 degrees 28 minutes 35 seconds West 50.0 feet to a point; thence, continuing with the Western right of way line of US Highway \$117 South 25 degrees 47 minutes 05 seconds West 100.0 feet to the point of intersection of the Western right of way line of US Highway \$117 with the Northern right of way line of Garden Place Drive; running thence, with the Northern right of way line of Garden Place Drive North 89 degrees 23 minutes West 258.46 feet to the point of Beginning, containing 0.972 acre more or less.
