Beginning at an iron rod at the point of intersection of the western right of way line of U.S. Hwy #421 (150.0 foot right of way) with the northern line of a 60.0 foot wide perpetual road right of way as said right of way is described in Deed Book 828 at Page 185 of the New Hanover County Registry.
