Other pads had average wear on them. Rotary on right & left had to be replaced. No parts in stock. Had to bring Res #3 and put in service for Res #1.
- 4/2/75 1209 Responded to Blount & Martin, then south on Smithfield. Found 10-56. Said she had been in an auto accident. No auto or evidence of wreck. Woman looked as if she had been beaten up. Carried to Wake E.R.

- 4/4/75 0930 Responded to Central Prison tag shop. 10-70. One employee got too much smoke. Carried to Rex E.R.

- 4/7/75 0800 Old Rescue 3 taken to Station #2 for repairs and Rescue 1 picked up from Bobby Murray Chev.

The (now deceased) man refused to go to the hospital, but paid Beacon \$20.00 for their trip. Two hours later, his wife called back, and wanted Beacon to return. Upon Beacon's [arrival] the man was DOA. Wife now claims Beacon responsible for death. Man was conscious and walking around the first trip. Police unit did check in last time.
- 4/18/75 1337 Responded to #5 Fire Station. Carried [firefighter] W. E. Brooks to Rex E.R. Mashed finger in door of Car 5 while cleaning up.
- 4/19/75 0218 Responded to 10-50 outside of City near Garner off Rock Quarry Rd. Arrived to find car turned up in a gulley. Four black males and black female. Beacon transported two and Rescue transported three to Wake E.R. All were living Rescue 1 got [them].
- 4/19/75 0800 Long backboard left at Wake ER last night. Picking it up this morning.

- 4/19/75 2021 Res 1 transported Chief May's father-in-law from Wake ER to Health Center Rest Home.
- 4/20/75 1839 Responded to 10-50 [at] 2700 Rock Quarry Rd. Motorcycle accident. Beacon transported two, Rescue transported two to Wake ER. None of the victims appeared to have very serious injuries.
- 4/24/75 1327 Res 1 responded to verbal request to help look for 2 ½ year old boy missing for approx. two hours in Cloverdale off Old Garner Road. Boy was found and in perfect cond. by neighbor.

- 5/3/75 1836 Res 1 responded to 20 Chavis Way. Injured person (Beacon tied up). Trans. to Wake ER.
- 5/6/75 1023- Responded to 300 blk. W. Park Dr. City employee was up a tree cutting limbs and got hit on back of head and on right hand by large limb. Had been unconscious but was conscious when we arrived. Removed from tree with assistance of Truck 5 and crew. Carried to Rex E.R.
- 5/12/75 1837 Res 1 responded to 2115 Cowper Dr. (cardiac). Mr. Cooper (Asst. City Manager) had placed call to Headquarters. It was his neighbor's wife. Upon arriving at house the husband told us it was too late to do anything. After questioning him, we found out she was having difficulty breathing [at] 0613. And approximately 0630 she stopped [breathing] altogether. Police officers were on the scene and called all proper authorities. (Beacon answ. also.)
